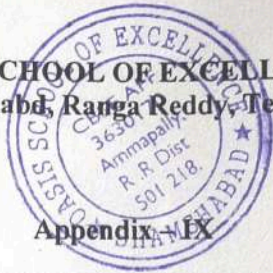

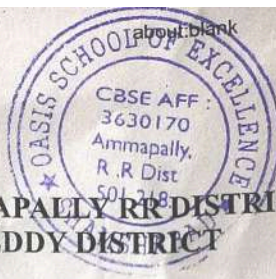



The MEO Shamshabad has recommended to accord provisional recognition for the classes PP to V (EM) during the years 2022-23 to 2031-32 through the letter 5<sup>th</sup> cited.

After careful examination of the proposals and recommendation of the MEO, Shamshabad Mandal, Ranga Reddy District and in terms of the orders issued in the references 5<sup>th</sup> cited, the District Educational Officer, Ranga Reddy District is hereby accorded Provisional Recognition for classes PP to V (EM) to Oasis School of Excellence, Ammapally, Narkhuda, Shamshabad Mandal, Ranga Reddy District for a period of (10) years commencing from the academic years 2022-23 to 2031-32 with instructed to follow the under mentioned instructions scrupulously.
